

MODEL DISPLAY

THE SIX CASES TO BE PRESENTED AT THE MODEL DISPLAY MUST HAVE A DIFFICULTY DETERMINED BY THE "DISCREPANCY INDEX", BORROWED FROM THE "DISCREPANCY INDEX" OF THE AMERICAN BOARD OF ORTHODONTICS.

IN PARTICULAR, THREE CASES MUST HAVE A DISCREPANCY INDEX EQUAL TO 10 OR MORE THAN 10 AND THREE OTHER CASES MUST HAVE AN INDEX OF 20 OR MORE THAN 20.

FOR EACH CASE IT WILL BE NECESSARY TO PRESENT SQUARED EITHER PLASTER OR RESIN MODELS, ACCORDING TO TWEED AND SORTED IN A BLACK RING BINDER WITH:

- CANDIDATE NAME AND INITIAL CASE DESCRIPTION
- ORTHOPANTOMOGRAPHY
- TELERADIOGRAPHY IN LATERAL-LATERAL PROJECTION
- CEPHALOMETRIC TRACING PERFORMED ACCORDING TO THE TECHNIQUE CHOSEN BY THE CANDIDATE
- FACIAL PHOTOGRAPHS (FRONTAL, PROFILE, SMILE)
- INTRAORAL PHOTOGRAPHS (OCCLUSAL ONES OPTIONAL)
- SHORT SUMMARY (MAXIMUM 300 WORDS) OF THE PLAN AND EXECUTION OF THE TREATMENT. A BLACK AND A RED DOT WILL MARK THE INITIAL AND FINAL RECORDS RESPECTIVELY.

LANGUAGE: ITALIAN (FOR ITALIAN CANDIDATES), ENGLISH (FOR INTERNATIONAL CANDIDATES). THOSE WHO HAVE OBTAINED IBO / EBO CERTIFICATIONS MUST BRING MODELS AND ORIGINAL DOCUMENTATION OF SIX OF THE EIGHT CASES PRESENTED.

MEMBERS ARE REQUIRED TO APPLY BY SENDING AN EMAIL TO ORGANIZATIONAL SECRETARIAT (SEGRETERIA@AIDOR.IT) BY MARCH, 15 2025.

CASE MODELS AND DOSSIERS HAVE TO BE SUBMITTED DIRECTLY ON THE DAY OF THE MODEL DISPLAY (THURSDAY 15 MAY): CANDIDATES MUST DEPOSIT THE MATERIAL IN THE "RED ROOM" OF THE THEATER BETWEEN 9 AND 10 AM. MODELS AND DOSSIERS CAN BE COLLECTED AT THE END OF THE CONGRESS, ON SATURDAY, MAY 17, FROM 2:30 P.M.

COMMUNICATION

THE ABSTRACT OF COMMUNICATIONS MUST BE SENT IN WORD FORMAT AND MUST NOT EXCEED 300 WORDS.

IN THE CASE OF A SCIENTIFIC CONTRIBUTION, THE PURPOSE, MATERIALS-METHODS, RESULTS AND CONCLUSION MUST BE DESCRIBED. IF THE COMMUNICATION IS CLINICAL, ITS CONTENT MUST BE CLEARLY SUMMARIZED.

LANGUAGE: ITALIAN (FOR ITALIAN CANDIDATES), ENGLISH (FOR INTERNATIONAL CANDIDATES).

TITLE AND ABSTRACT MUST REACH THE SCIENTIFIC COMMITTEE BY SENDING AN EMAIL TO ORGANIZATIONAL SECRETARIAT (SEGRETERIA@AIDOR.IT) BY MARCH 15, 2025. THE APPROVED WORKS MUST BE DELIVERED IN EITHER POWER POINT OR KEYNOTE FORMAT ON THURSDAY 15 MAY BETWEEN 9 AND 10 AM IN THE PRESS ROOM OF THE THEATER (ALTERNATIVELY IT IS POSSIBLE TO SEND THE PRESENTATION WITH THE SAME DEADLINE TO: SEGRETERIA@AIDOR.IT).
